RETURN AND REFUND POLICY

Returns

Our return policy lasts 14 days from delivery. If 14 days have gone by since you received your item(s) and you have not requested Tracer Mounts you want to return your item(s), unfortunately we can't offer you a refund or exchange.

To be eligible for a return, your item(s) must be unused and in the same condition that you received it/them. It/they must also be in the original and undamaged packaging.

To complete your return, we require a fully filled in return form and a copy of your invoice. Returned items without copy of your invoice can not be refunded. No or only partial refunds are granted in case any item is not in its original condition, is damaged or missing parts for reasons not due to our error.

Any item that is not received by Tracer Mounts within 30 days after your return request will not be refunded.

Refunds

Once your return is received and inspected, we will send you an email to notify you that we have received your returned item(s). We will also notify you of the approval or rejection of your refund.

If your refund request is approved, then your refund will be processed, and a credit will automatically be applied to your credit card or original method of payment within 14 days.

Late or missing refunds

If you haven't received a refund after 14 days after our refund notification yet, first check your bank account again.

Then contact your credit card company, it may take some time before your refund is officially posted. Next contact your bank. There is often some processing time before a refund is posted.

If you've done all of this and you still have not received your refund yet, please contact us at payments@tracermounts.com.

Exchanges and warranties

We only replace items if they are defective or damaged due to our error, 2 years from the date you received your item(s). If you need to exchange an item for the same item, send us an email at helpdesk@tracermounts.com and explain us the problem, together with some clear pictures. After our approval, send only your defective or damaged item together with a copy of your invoice to the shipping address below.

Shipping

To return your product(s), you should send all well packed item(s), together with return form and invoice copy, to:

Please state your own name and address on the package as well.

You will be responsible for paying for your own shipping costs for returning your item. Shipping costs for returns are non-refundable. If you receive a refund, any cost of insufficient return shipping will be deducted from your refund.

If you are shipping items over 50 euros, you should consider using a trackable shipping service or purchasing shipping insurance. We don't guarantee that we will receive your returned item, refunds will be only processed for actual returned items. Depending on where you live, the time it may take for your exchanged product to reach you, may vary.

PRIVACY STATEMENT

SECTION 1 - WHAT DO WE DO WITH YOUR INFORMATION?

When you purchase something from our webshop, as part of the buying and selling process, we collect the personal information you give us such as your name, address and email address.

When you browse our store, we also automatically receive your computer's internet protocol (IP) address in order to provide us with information that helps us learn about your browser and operating system.

With your permission, we may send you emails about Tracer Mounts, new products and other updates.

SECTION 2 - CONSENT

How do you get my consent?

When you provide us with personal information to complete a transaction, verify your credit card, place an order, arrange for a delivery or return a purchase, we imply that you consent to our collecting it and using it for that specific reason only.

If we ask for your personal information for a secondary reason, like marketing, we will either ask you directly for your expressed consent, or provide you with an opportunity to say no.

SECTION 4 – DATA STORAGE

Our website and webshop are hosted on Hosting2go. They provide us with the online e-commerce platform that allows us to sell our products and services to you.

Your data is stored through Hosting2go's data storage, databases and the general Hosting2go, Wordpress and Pay.nl applications. They store your data on a secure server behind a firewall.

Payment:

If you choose a direct payment gateway to complete your purchase, then Pay.nl stores your credit card data. It is encrypted through the Payment Card Industry Data Security Standard (PCI-DSS). Your purchase transaction data is stored only as long as is necessary to complete your purchase transaction. After that is complete, your purchase transaction information is deleted.

All direct payment gateways adhere to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, MasterCard, American Express and Discover.

PCI-DSS requirements help ensure the secure handling of credit card information by our store and its service providers.

- visit, no data held, Persistent for 30 minutes from the last visit, Used by our website provider's internal stats tracker to record the number of visits
- uniq, no data held, expires midnight (relative to the visitor) of the next day, Counts the number of visits to a store by a single customer.

- cart, unique token, persistent for 2 weeks, Stores information about the contents of your cart.
- secure_session_id, unique token, sessional
- storefront_digest, unique token, indefinite If the shop has a password, this is used to determine if the current visitor has access.
